

HIST 625 Topics in Ottoman Cultural History

The course is intended as an interdisciplinary forum for the discussion of key topics in cultural history as they are related to Ottoman history with the view of learning about and developing methodologies of how to study this field. While surveying these subjects through both primary and secondary sources, attention will also be paid to how our discussion can tie in with cultural history as treated in fields other than Ottoman history, such as global or western early modern history. Although we will be making occasional references to later and earlier periods, the focus will be on the period between ca. 1300 and 1700.

Assessment: oral presentations: 10%, participation in in-class discussion: 10%, final research paper (ca. 30 pages long, 12 pt, Times New Roman, 1" margins): 80% on a topic developed in conversation with the instructor.
