Course Overview

This course will examine a variety of topics in labor markets. First, we will develop theoretical models of labor supply, labor demand and the interaction of the two. These models will then be applied to understand issues such as wage determination, wage differentials, human capital investment, migration and discrimination, unemployment and labor policies, and unions.

Familiarity with topics covered at the intermediate microeconomics level is required. During the course students will learn about the data and the empirical methods that labor economists employ to quantify the relationships developed in theoretical models of the labor market. The course also aims to illustrate how economic reasoning can be used to address policy relevant questions.

Additional readings will be assigned throughout the semester regarding the topics covered in class. There will be in class discussion of these assigned readings. Participation in discussions will be graded. There will be occasional unannounced quizzes on assigned readings and other course material covered in class.

This is an online course that will be taught as synchronous-live sessions. We may use either Google Meet or Zoom. Video recordings of the lectures will be posted on SuCourse+. If you miss a class, it is your responsibility to go over the course material.

Grading

Midterm: 40 %, Class Performance and Quizzes: 20 %, Final Exam: 40 %

The course grade is solely based on the grading scheme stated on the syllabus. There will be no exceptions to this (like doing additional assignments, writing a term paper etc.). A student who is not present during the start of a quiz will be given a grade of 0.

• Teaching format:

- The course will be taught in a hybrid format with in-class and online hours as listed above.
- The online lectures will only be delivered through Zoom while in-class lectures will be simultaneously delivered in class and through Zoom.

- Rotation rule for in-person attendance:
 - O Due to limited seating capacity of classrooms, the rotation rule determined by the university administration will be implemented.

We will continue implementing this rule if necessary after observing the attendance numbers in the first two weeks.
