Course Description and Objectives:

The goal of this class is to give you a basic understanding of institutional organization of local governments, current challenges faced by local governments, and how local politics interact with local governments. The course starts with a clarification of key concepts. Then, we will discuss different organizational characteristics of local governments from a comparative perspective. The next section will focus on representation, participation, and local political actors who might be involved with local policy formation and implementation. Then, we will focus on policy formation and implementation in general as well as in specific areas such as housing, environment, and water provision. The course will finish with a discussion of local governments' links with international actors and organizations. The course tries to strike a balance between policy and theoretical debates as it intends to appeal to both students who are interested in further academic studies on local government and students who are planning to pursue a career related to local politics or public policy.

Student Responsibilities:

(1) Required Reading and Participation.

You are expected to complete the assigned readings before class. All readings will be available through SUCourse.

You are also required to attend and participate in class discussions. The part of your grade based on class participation will be determined by (1) attendance and (2) active participation.

(2) Exams.

There will be four announced quizzes based on the assigned readings and class discussions. The dates will be announced two weeks in advance.

(3) Policy Paper

For this paper, please pick a policy area and a municipality. You need to conduct research on what this particular municipality did in this particular policy area for at least two electoral periods. You will need to use municipality reports, documents, webpages, interviews to collect this information. The paper will have two sections. In section one you will describe the policy formation and implementation process. In the second part you will discuss the challenges in the policy formation and implementation processes and possible explanations for the policy choices and outcomes. You are highly encouraged to talk with me about your municipality and policy area early in the semester.

(4) Presentation

You will present your preliminary findings for the policy paper (3) in the last week of the semester.

Your course grade will be based on the four quizzes (40%), the final paper (40%), class participation (10%), and presentation (10%).
